



“Frequently Asked Questions under UCP 600” is a series of eleven volumes containing 1700 questions and answers relating to the articles of UCP 600, documentary credits in general, ISBP and URR issues.

The main features are:

- All questions were either asked during workshop and seminar events that have been conducted by Gary Collyer or submitted to him by email up to and following the implementation of the UCP 600 on July 1st, 2007;
- No simple yes or no answers given;
- Full descriptive answers provided;
- No questions are repeated, although there are questions on similar themes that have been asked from a different perspective; and
- Questions and answers are given for every article of UCP 600.
- Volume I (September 2007) consists of 220 questions and answers covered in 46 A4 pages;
- Volume II (March 2008) consists of 198 questions and answers covered in 48 A4 pages;
- Volume III (September 2008) consists of 182 questions and answers covered in 46 A4 pages;

- Volume V (September 2009) consists of 200 questions and answers covered in 56 A4 pages;

- Volume VIII (March 2011) consists of 115 questions and answers covered in 48 A4 pages.
- Volume IX (September 2011) consists of 120 questions and answers covered in 48 A4 pages.
- Volume X (March 2012) consists of 100 questions and answers covered in 50 A4 pages.
- Volume XI (March 2013) consists of 100 questions and answers covered in 48 A4 pages.
